Team 1: News commentator goes after Walmart "greed"



MSNBC news commentator <u>Keith Olbermann introduced the story</u> of Debbie Shank, a 52-year-old former Walmart employee and mother of a soldier killed in Iraq who suffered severe brain damage after getting hit by a truck and was subsequently sued by Walmart to recover \$470,000 in medical expenses (paid out by group coverage). <u>Shank had won a substantial settlement from the trucking company</u> and, after legal fees, took home \$417,000, prompting Walmart's suit of their ex-worker.

Olbermann declared Walmart his "Worst Person in the World" and has subsequently mentioned the issue every night since. Walmart shortly thereafter dropped their suit, but suffered a tarnished reputation.



Team 3: "Union busting" Walmart's history of treating workers poorly

A U.S. labor agency has accused Walmart of using illegal tactics to deter unionizing at a California store. The National Labor Relations Board (NLRB) said it had issued a complaint late Wednesday alleging Walmart interrogated workers at the Eureka, California, store about their union activities, removed pro-union flyers from a break room, and threatened employees who distributed union literature in violation of U.S. labor law.

This comes after years of complaints about Walmart, including a lawsuit regarding janitors being locked in stores during their shifts (2004) and being sued by undocumented workers (2010).

Team 4: Walmart employee found dead in oven at store

A 19-year-old Walmart employee's body was found in a store's walk-in oven in Canada last month, police said. The young woman was identified as Gursimran Kaur by the Maritime Sikh Society in Nova Scotia, which launched a fundraiser on behalf of the family.

Halifax police were uncertain in their investigation "where the cause and manner of death have been confirmed," they've said.

"We urge the public to be mindful of sharing speculative information on social media," police said last week in a statement. "Please be aware of the impacts that speculation could have on family, colleagues and loved ones of the woman." However, according to emergency audio from first responders, the woman was believed to have been "locked" in somehow.

In another location, a customer blasted the retailer on social media for having low stock on regular goods, but also providing no restrooms for shoppers, only port-o-potties outside the store.

Team 6: Walmart's history with disability lawsuits, judgements

Another <u>former employee with a seizure disorder sued</u> after being dismissed because of absences despite putting forth a disability leave request with her employer. This <u>follows a string of other suits</u> by employees, in conjunction with the EEOC.
